Grand Central Landfill Potential Closure



Loss of Vital Community Benefits & Services

WM's Grand Central Landfill provides necessary waste disposal services for the Slate Belt, Lehigh Valley and Pocono Region. The facility is operated to the highest environmental protection and safety standards, working with local governments and nearby property owners to be the best possible neighbor it can be.

Grand Central's direct operating expenditures produce approximately \$45.3 million in indirect and induced economic value in Pennsylvania, along with 126 jobs and \$7.6 million in payroll. Construction of the Eastern Expansion will provide Northampton County with a one-time economic investment of \$42.3 million, with total construction value of the expansion during the facility's years of operation at \$222 million.

The potential closure of Grand Central would have far-reaching and negative impacts on the Slate Belt's municipal governments, economic development programs, schools and non-profit organizations. Provided below is a summary of those impacts:

Bottom Line: If the landfill closes, taxes will go up to cover the cost of emergency services, capital projects, solid waste and recycling services, and other important programs in these communities

Think About This: The community investments and in-kind services provided by Grand Central each year amount to approximately \$6.8 million. There is not another entity - of any kind - in the Slate Belt that will replace these important contributions to improve the quality of life of Slate Belt residents.

^{**}Amounts reflect Grand Central's direct costs to provide these services to Pen Argyl and Wind Gap. Actual amounts could be considerably higher due to bids from new haulers, including labor costs, increased fuel expenses associated with transporting solid waste to more distant landfills and higher tipping fees at those landfills.
