HOUSEHOLD HAZARDOUS WASTE (HHW) COMMUNITY DROP-OFF EVENT

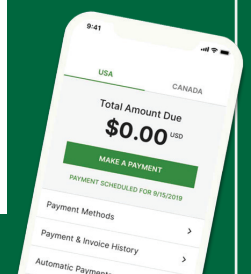
Many household waste items require special handling before they can be properly disposed. At home, a quick stroll through your garage is enough to spot several hazardous items. Although these waste materials have different properties, they share the same disposal limitations: they should not go in your trash or recycling carts. Improper disposal can lead to fires, expose our drivers to unnecessary risks, and cause waste contamination.

To encourage responsible disposal and prevent illegal dumping, WM will host a community drop-off event at the Quincy Transfer Station on Saturday, **June 1, 2024, from 9 am to 2 pm** (see reverse for the address). On that day, residents can dispose of HHW, major appliances, bulky items, and electronic waste at no additional cost (no commercial waste). **Liquids or sludges, cement, dirt, asphalt, concrete, and other hazardous or infectious waste will not be accepted.**

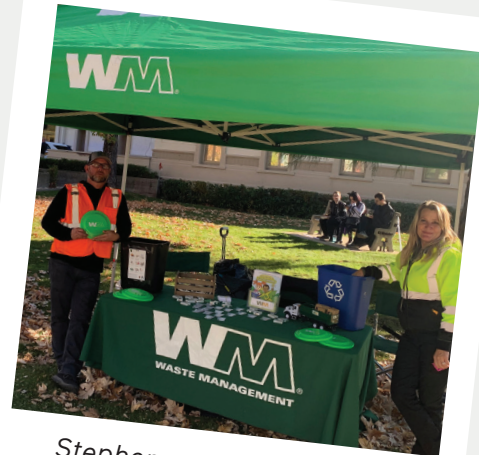
