Cart and Bin Set Out Information

Wheel carts/bins to curb by 7:00 a.m. on your collection day. Collection will be provided from 7:00 a.m. to 7:00 p.m. Carts/bins may be set out for 24 hour period only for the purposes of collection.



Service holidays are Thanksgiving, Christmas, New Year's Day. When holiday lands on weekday, collection will be one day later for rest of week.

Reduced Rate Recycle & Compost – MORE THAN 2 YARDS

For businesses with more than two (2) cubic yards of trash service per week, compostables and recycling services are 50% of regular garbage rates.

Free Small Business Services

FREE Recycling & Compostables Collection - 2 YARDS OR LESS

Businesses with two (2) cubic yards or less of trash service/week are eligible for free recycling and compostables carts – for a total of 264 gallons in separated materials. (510) 613-8700

FREE battery collection for cart customers: Tape a clear plastic, sealed bag of batteries (all alkaline, small button, rechargeable and cell phone batteries) onto your GRAY curbside recycling cart.



Services Available to All Businesses



Program to safely recycle batteries or lamp products: Businesses can purchase battery tracker, fluorescent tube, and other types of mail-back boxes by ordering online at wmlamptracker.com or calling 1-800-664-1434 Mon-Fri 7 a.m. to 5 p.m. CT.



Program for Free CFL bulb recycling: Businesses can order free mail-back CFL products (TLC – Tri-Guard® or VLC – Mercury VaporLok®). Call 510-613-8700 and let the agent know you'd like to order the free CFL LampTracker products for your Emeryville business.



Hazardous Waste: There is a drop-in program for Alameda County businesses that accepts: electronics and small appliances, latex paint, aerosol cans, fluorescent lamps, and household batteries. Visit stopwaste.org/hhw. For disposing paint only, visit Paintcare.org.



FREE indoor recycle & compost containers: Stop Waste and the City of Emeryville offer free color-coded indoor containers for proper sorting (up to \$500). To apply: www.StopWaste.org/free-green-bins www.ci.emeryville.ca.us/1185

State and County Composting and Recycling Laws

California State law, SB 1383, aims to keep food and other compostable materials ("organics") out of landfills to reduce emissions that contribute to climate change. In Alameda County, the law is implemented and enforced under the Organics Reduction and Recycling Ordinance. In addition to sorting correctly, business and multifamily properties must set up adequate collection service and place color-coded and labeled indoor compost and recycling bins next to all trash bins. Avoid Contamination and Overage Charges

Contamination surcharges will be implemented when incorrect materials are discovered in the recycling or compost carts or bins (after two warnings).
